CHILD PROTECTION POLICY

Executive Summary

Stichting Tan-kids is a Dutch voluntary organization with a vision "that every child in this world has the right to be cared for, to be protected and loved". In our mission to support local organizations in Tanzania, we strive seeing children in Tanzania growing up happy and healthy in a loving family and a safe, child friendly community.

This policy sets out common values, principles and beliefs and describes the steps that will be taken in meeting our commitment to protect children. Tan-kids is committed to protecting children from all forms of physical, emotional or mental violence, injury or abuse, neglect, maltreatment or exploitation.

We believe that child protection is crucial to ensuring that children have the rights, confidence and environment in which they can make choices, express their views and communicate effectively with other children and adults. Children cannot become empowered change agents to improve their lives and that of their families and communities if they are not safeguarded from abuse, discrimination and harm of any kind, be it physical, sexual, emotional or neglect

Goal

To protect children from abuse of all kinds in the implementation of all our project activities.

Definitions

(Unless otherwise stated, definitions are adapted from Save the Children Alliance.)

A child: In accordance with the United Nations Convention on the Rights of the Child, 'child' means every human being below the age of 18 years unless under the law applicable to the child, maturity is attained earlier.

Vulnerable children: Children who are at risk of abuse, such as (orphaned) children with physical and mental disabilities, homeless children, child sex workers and children impacted by poverty and disasters.

Child protection: An activity or initiative designed to protect children from any form of harm particularly arising from child abuse or neglect.

Abuse: Is an act of ill treatment that can harm or is likely to cause harm to a child's safety, wellbeing, dignity and development. Abuse includes all forms of physical, sexual, psychological or emotional ill treatment.

Child abuse: will be committed regardless of any justification or reason that may be provided for the ill treatment including discipline, legal sanction, economic necessity, the child's own consent to it, or in the name of cultural and religious practice.

- Physical Abuse: involves the use of violent physical force so as to cause actual or likely physical injury or suffering, (e.g. hitting, shaking, burning, female genital mutilation, torture.)
- Emotional or psychological abuse: includes humiliating and degrading treatment such as bad name calling, constant criticism, belittling, persistent shaming, solitary confinement and isolation.

Tan Kids

Sexual Abuse: includes all forms of sexual violence including incest, early and forced marriage, rape, involvement in pornography, and sexual slavery. Child sexual abuse may also include indecent touching or exposure, using sexually explicit language towards a child and showing children pornographic material.

Neglect: is deliberately, or through carelessness or negligence, failing to provide for, or secure for a child, their rights to physical safety and development, resulting in significant impairment of the child's health or development including a failure to thrive emotionally and socially. It can include the failure to provide compulsory education or access to medical care. These actions or failure to act must be intentional. For example, a parent who willfully withholds primary education from a child despite having the necessary resources for that child to receive a primary education is neglecting that child.

Child exploitation: is the use of children for someone else's advantage, gratification or profit often resulting in unjust, cruel and harmful treatment of the child. These activities are to the disadvantage of the child's physical or mental health, education, moral or psychosocial development.

- Sexual exploitation: is the abuse of a position of vulnerability, differential power or trust for sexual purposes; this includes profiting monetarily, socially or politically from the exploitation of another as well as personal sexual gratification.
- Economic exploitation: of a child is the use of the child in work or other activities for the benefit of
 others. This includes child labor, domestic work (beyond a reasonable or necessary level of
 household work), recruitment and involvement of children in armed conflict, use of children for
 criminal activities including the sale and distribution of narcotics, involvement of children in any
 harmful or hazardous work.
- Child pornography: In accordance with the Optional Protocol to the Convention on the Rights of the Child, 'child pornography' means 'any representation, by whatever means, of a child engaged in real or simulated explicit sexual activities or any representation of the sexual parts of a child for primarily sexual purposes.'
- Child-sex tourism: The sexual exploitation of children by men or women who travel from one place to another, usually from a richer country to one that is less developed, and there engage in sexual acts with children.
- Bullying: is the repeated and deliberate use of aggression and power to cause physical pain or emotional distress. Bullying can be verbal, physical, unpleasant gestures, social coercion, social exclusion, or any combination of these.

Violence: is defined in the Convention on the Rights of the Child as 'all forms of physical or mental violence, injury and abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse.' WHO defines violence as 'the intentional use of physical force or power, threatened or actual, against a child, by an individual or group, that either results in or has a high likelihood of resulting in actual or potential harm to the child's health, survival, development or dignity.'

Corporal or physical punishment (and the threat of it): includes hitting the child with the hand or with an object (such as a cane, belt, whip, shoe, etc); kicking, shaking, or throwing the child, pinching or pulling their hair; forcing a child to stay in uncomfortable or undignified positions or to take excessive physical exercise; and burning or scarring the child.

Humiliating or Degrading Punishment: takes various forms such as psychological punishment, verbal abuse, ridicule, isolation, and ignoring the child.

Harm: is the result of the exploitation, violence, abuse and neglect of children and can take many forms, including impacts on children's physical, emotional and behavioral development, their general health, their family and social relationships, their self-esteem, their educational attainment and their aspirations.

Working with children: Working in a position that involves regular contact with children, either under the position description or due to the nature of the work environment.

Personnel: Personnel either employed by an organization, or engaged by an organization on a sub contract basis, or engaged by an organization on a voluntary or unpaid basis.

Criminal record check: A check of an individual's criminal history record.

Police clearance certificate: The certificate showing the results of a criminal record check, issued by the police or other authority responsible for conducting such checks.

Guiding principles

The child protection policy is guided by these principles:

Zero tolerance of child abuse: Child abuse is never acceptable. Tan-kids' mission seeing children in Tanzania grow up healthy and happy, means a commitment to ensuring that all children in our projects are protected and safeguarded from harm.

Tan-kids will not knowingly engage, directly or indirectly, to anyone who poses an unacceptable risk to children, or partner with an organization that does not meet Tan-kids' child protection compliance standards in their operations and activities.

Recognition of children's interests: Tan-kids advocates that all volunteers and partners commit to upholding the United Nations Convention on the Rights of the Child.

Sharing responsibility for child protection: Ensuring that all people partnering with Tan-kids are aware of the need to protect children and that systems are in place to protect children. Supporting Tan-kids' volunteers and partners to minimize the risks to children. Taking care to ensure that children who have experienced trauma and psychosocial distress are protected from potential abuse and exploitation.

Risk management approach: Ensuring that action is taken to support and protect children where concerns arise regarding possible abuse. Ensuring that all volunteers connected with Tan-kids are clear on what steps to take where concerns arise regarding the safety of children.

Awareness raising and education: Ensuring that all volunteers and partners of Tan-kids are aware of and understand the problem of child abuse and the risks to children. Using Tan-kids and local partners' expertise in psychosocial support to highlight knowledge of child protection, including with children themselves. Ensuring that Tan-kids and partners draw attention to the problems of child abuse, neglect and exploitation and the need to ensure proper child protection procedures to protect and support such children.

Statement of commitment

Tan-kids' vision is "that every child in this world has the right to be cared for, to be protected and loved". Tan-kids recognizes that the abuse and exploitation of children happens in all countries across the world.

All child abuse involves the abuse of children's rights. Children in situations of poverty, conflict and HIV face many forms of potential abuse.

Purpose

To ensure that:

- All Tan-kids' volunteers and partners uphold children's rights and promote the protection of children.
- Partner organizations are assisted in making sure children in their care, or with whom they interact, are safeguarded.
- Positive steps are taken to ensure the protection of children.
- Any concerns around child abuse raised by children, staff or others are taken seriously.
- Children, staff or other adults who raise concerns or who are the subject of concerns are supported and protected.
- Appropriate and effective measures are taken in initiating or co-operating with any subsequent process of investigation

CODE OF CONDUCT

Tan-kids' commitment to enhancing children's overall development means a commitment to ensuring that all children with whom Tan-kids is in contact, directly or indirectly through volunteers and partners, are safeguarded from harm.

Tan-kids recognizes that children are individuals with their own needs, wishes and feelings. In all cases, children must be listened to and supported as a priority. All children have an equal right to protection, including those who are disabled and living with HIV and regardless of gender, sexuality, culture, religion or legal status.

Tan-kids also recognizes that adults affected by the policy have a right to be provided with information about the child protection policy, training to understand its application, and support in the event of an allegation or report.

This code of conduct applies to

- all volunteers and board members of Tan-kids
- all volunteers and board members who are undertaking activities in partnership with Tan-kids.
- institutions and organizations that are in partnership with Tan-kids.

The code of conduct is to be reviewed as and when need arises and adapted for inclusion, in all partner contracts and endorsed by the Tan-kids board members and the director.

It is important for all staff, volunteers and people contracted to Tan-kids to:

- be aware of situations which may present risks and manage these
- plan and organize the work and the workplace so as to minimize risks
- as far as possible, be visible in working with children
- ensure that a culture of openness exists to enable any issues or concerns to be raised or discussed
- ensure that a sense of accountability exists between staff so that poor practice or potentially abusive behavior does not go unchallenged
- talk to children about their contact with staff or others and encourage them to raise any concerns
- empower children discuss with them their rights, what is acceptable and unacceptable, and what they can do if there is a problem.

Confidentiality:

All those who adhere to this code of conduct must be extremely careful in protecting personal and private-sensitive information. The status of the child suspected of being abused should not be disclosed to any persons outside of the reporting structure without the informed written consent of the child.

Confidentiality is difficult. When a child discloses abuse, the person who is party to the disclosure cannot promise to keep any secrets since they are under obligation to report the abuse. For this reason, it is essential to make clear the fact that it may not be possible to keep such information wholly confidential. The reporting procedure should be explained in a manner appropriate to the child's situation. Ideally this should be done before any such matter arises.

Where possible and appropriate, a written statement could be used to get the child's permission to share the information with selected other people according to the reporting process. This process must be

discussed with the child to ensure that he/she knows what to expect at all times. The child should be kept informed at all times of the discussion and consulted on all decisions.

Records will be kept in a locked, safe place which is not accessible to those outside the reporting process. Information may only be shared with relevant parties and it must always be done in such a way that confidentiality is maintained.

Declaration of Acceptance

I will:

- Commit to a background check if requested by Tan-kids.
- Openly declare any allegations or investigations or transgressions or existing criminal records upon me regarding child offences.
- Treat children with respect regardless of race, gender, religion, ethnic or social origin, disability, birth or other status
- Not use language or behavior towards children that is inappropriate, harassing, abusive, sexually provocative, demeaning or culturally inappropriate.
- Not engage children in any form of sexual activity or acts, including paying for sexual services or acts, with children below the age of consent.
- Wherever possible, ensure that another adult is present when working in the proximity of children.
- Not invite unaccompanied children into my home, unless they are at immediate risk of injury, in physical danger or when there are other persons in the home.
- Not sleep close to unsupervised children unless absolutely necessary, in which case I must obtain my supervisor's permission, and ensure that another adult is present.
- Use any computers, mobile phones, or video and digital cameras inappropriately, and never to exploit or harass children or to access child pornography through any medium (see also 'Use of children's images for work related purposes')
- Refrain from physical punishment or discipline of children.
- Refrain from hiring children for domestic or other labor which is inappropriate given their age or developmental stage, which interferes with their time available for education and recreational activities, or which places them at significant risk of injury.
- Comply with all relevant country and local legislation, including labor laws in relation to child labor.
- Immediately report concerns or allegations of child abuse in accordance with appropriate procedures.
- Not act in ways that may be abusive or may place a child at risk of abuse.
- Not behave physically in a manner which is inappropriate or sexually provocative towards children.
- Refrain from acting in ways intended to shame, humiliate, belittle or degrade children, or otherwise perpetrate any form of emotional abuse.
- Ensure that child participation in programs does not exploit, shame, humiliate, undermine and degrade children or result in any form of emotional abuse to children.
- Report on any possible or suspected child abuses cases using the recommended tools as provided by Tan-kids.

Use of children's images for work related purposes

When photographing or filming a child for work related purposes, I must:

- Before photographing or filming a child, obtain consent from the child and a parent or guardian of the child. As part of this I must explain how the photograph or film will be used.
- Ensure photographs, films and videos present children in a dignified and respectful manner and not in a vulnerable or submissive manner. Children should be adequately clothed and not in poses that could be seen as sexually suggestive.

Tan-kids considers acceptance of this code of conduct as a precondition of any partnership with Tan-kids for any and all persons mentioned above. Tan-kids will keep the Declaration of Acceptance on file.

I understand that it is my responsibility, as a volunteer or partner of Tan-kids, to avoid actions or behaviors that could be construed as child abuse when conducting our project activities. I hereby certify that I have read and understand Tan-kids' Child Protection Policy and agree to abide by its contents.
